#### III.A. NEW 5127.1 Improve Completion Rates of FAFSA

E. Eaton said this policy is in response to new laws. Dr. Petrone said Coventry has been doing this and it is not new to us.

#### IV.G. 5141.21 Administration of Medications in Schools

# IV.I. 5146 Physical Activity, Undirected Play, and Student Discipline

E. Eaton reviewed the changes to the policy. Dr. Petrone said these are minor adjustments due to push back received after the new law was passed.

The Committee discussed details related to recess and PE class.

### IV.J. 6164 Curricular Exemptions

E. Eaton noted the changes to this policy. Dr. Petrone said this adds an additional opt out for parents related to gun safety. J. Beausoleil confirmed that these opportunities to opt out are all included in the law - they are not specific to Coventry. To further clarify this, J. Beausoleil asked that the second line down be adjusted to read "*per state statute*, the Board Coventry Board of Education (the "Board") shall permit curricular... "

C. Rossignol asked how or when parents are to opt out. Dr. Petrone said parents can opt out anytime in advance of the instruction; it does not need to take place at the beginning of the school year.

#### IV.K. 9111.2 Code of Conduct for Board Members

Dr. Petrone said the original language was very minimal. J. Beausoleil said Shipman and Goodwin is recommending this for many districts. E. Eaton and E. Marchand agreed. C. Rossignol said she believes much of it is subjective.

J. Beausoleil said the only real recourse is censure, which does not have any real "teeth" to it.

E. Marchand asked C. Rossignol what her reservation was. C. Rossignol said the language is overarching and could be taken in different ways. E. Marchand asked if she had any suggestions. C. Rossignol said she needs time to sit on it and asked if it could be held back for further discussion at Policy.

The Committee agreed to revisit the policy before sending it forward to the full Board.

C. Rossignol noted page 1, under Construction and Posting of Agenda, section B, item 2 and asked that it be clarified as 72 *business* hours. The Committee agreed that it would be 72 business hours consistently for requests and that business would be added to notification timeframes.
